

DO SOLEMNLY AND SINCERELY DECLARE as follows:-

1. In or about 1942 a Society known as The Psychic Trust Society was formed and I was a founder member of that Society (hereinafter called "the Society").
2. I am at present the Honorary President of the Society and also a Trustee of the Society.
3. During the latter part of 1953 the opportunity arose to purchase some property for the Society and ultimately property known as number 44 Parkfield Road, Liverpool 17 was purchased on 22nd February 1954 by John McNaught, Michael Frank Bovenizer and Harold Joseph Olney. A copy of that Conveyance is now produced to me and marked 'A' and is hereinafter referred to as "the Conveyance".
4. The Conveyance conveyed the property to the said John McNaught Michael Frank Bovenizer and Harold Joseph Olney in fee simple on trust to sell the same with power to postpone the sale thereof but the Conveyance did not state that the property was held for and on behalf of the Society which was the intention of the parties thereto.
5. At the time of the purchase of the said property I was on the Committee of the Society and I do know that the property was bought for and on behalf of the Society and with monies of the Society.
6. As at the 22nd day of February 1954 the Trustees of the Society were the said John McNaught, Michael Frank Bovenizer and Harold Joseph Olney.
7. The said Harold Joseph Olney died on the 28th day of October 1955 at 44 Parkfield Road, Liverpool 17 and I now produce a copy of his death certificate marked 'B'.
8. The said John McNaught died on the 23rd day of April 1956 at Derby Road, Widnes, Lancashire and I now produce a copy of the Probate of his Will dated 18th September 1936 marked 'C'.
9. The said Michael Frank Bovenizer died on the 6th day of February 1961 at Ingledene, Higher Foxdale, St. Johns, Isle of Man and I now produce a copy of his Death Certificate marked 'D'.

According to the Minute Book of the Society the Trustees were confirmed as at 10th March 1964 as myself A Robert Robertson and H Riley.

11. On the 8th day of March 1966 the said A Robert Robertson retired as Trustee and in his place Mabel Gwendoline Robertson was appointed as Trustee to act jointly with myself and the said H Riley.

12. The said H Riley retired as Trustee on the day of 19

13. On the 9th day of July 1968 Mary Beatrice McNaught was appointed as Trustee but the said Mary Beatrice McNaught died on the day of 1972.

14. As at the date of this Declaration the Trustees of the Society are myself the said Muriel Wyatt McNaught of 42 Brooke Road East, Liverpool 22 the said Mabel Gwendoline Robertson of 12 Circular Road West, Liverpool 11 and Oldfield of

15. No Transfer or Conveyance of the property has been made at any time either to Trustees or elsewhere since the property was purchased under and by virtue of the Conveyance of 22nd February 1954.

16. Since the 22nd day of February 1954 the Society has been in full free and undisturbed possession of the property for its own benefit and without any adverse claim whatsoever. Throughout that period the title deeds have remained in the possession of the Society.

17. I depose as above from my own knowledge of the position and also from my having examined the Minute Books and other records of the Society.

AND I make this solemn declaration conscientiously believing the same to be true and by virtue of the provisions of the Statutory Declarations Act 1835.
